Legal research using traditional tools can be time-consuming and frustrating, with the important cases randomly distributed throughout results lists. Fastcase has developed a suite of smarter research tools that make your work simpler, smarter, and more effective.

FIND THE NEEDLE IN THE HAYSTACK WITH SMARTER SORTING AND FILTERING TOOLS.

Traditional research services present a conundrum: either scroll through screen after screen of irrelevant results, or narrow your search and run the risk of excluding important cases. Using the integration analysis and sorting tools together, you can quickly bring the most frequently cited cases in your search results – the ones most likely to be seminal – to the top of your results list with a single click.

GET THE BIG PICTURE WITH EXCLUSIVE AND ONE-OF-A-KIND VISUALIZATION TOOLS.

Fastcase is the only place you'll find an Interactive Timeline—a 4-dimensional, visual representation of your search results—that makes seminal cases jump off the page. Long lists of text search results (even when sorted well) only show one ranking at a time. The exclusive Interactive Timeline displays all of your search results on a single map, illustrating how relevant each case is based on your search terms, how many times each case has been "cited generally" by other cases in our database, and how many times each case has been cited only by the super-relevant cases within the search result ("cited within" search results).

This visual representation provides an analytic tool more striking and informative than any list of search results – you can see peaks and valleys in the volume of litigation over a particular issue, often signaling shifting trends in the legal framework.
